**DEADLINE FOR SUBMISSION OF ABSTRACTS: September 1, 2024**

When submitting the abstract, please indicate the topic and type of presentation and participation (Plenary Conference, Oral or Poster Presentation, Virtual or Off-line Participation) in which you would like to be included. See the summary template at the end of the document. Authors must provide their abstract in English. The Scientific Committee will have the right to choose the type of presentation, whether in the form of an oral presentation or a poster.

The Organizing Committee will inform the authors via email about the acceptance of their contributions on a date no later than November 1, 2024.

The organizers will publish the full scientific program through the website with the keynote address by prominent guest speakers.

### ***Publication of the memories of the Meeting***

The book of abstracts will be published in the Journal of Pharmaceutical and Food Sciences, free of charge <https://revistas.uh.cu/rcfa>. Prior opinion of the committee

Scientific journal may accept full papers as long as they comply with its editorial requirements.

## **Guidance template for writing and structuring summaries presented to ECFA 2024.**

When sending your abstract to the Scientific Committee you must verify that it complies with the structure here proposal. If you do not meet this requirement you may be rejected.

### **Article title**

It should be informative, specific and unambiguous. You must accurately and clearly communicate such important matters as the research topic and study design (if important). It should not include acronyms. It should not exceed 15 words.

### **Presentation of authors' data**

Manuscripts must have the full names of the authors. Institutional affiliation, ORCID number and the corresponding author's email address.

## Summary

This electronic document is a "live" template and already defines the style of your summary. \*FUNDAMENTAL: Do not use symbols, special characters, footnotes or mathematics in the title or summary of the article.

(Summary)

Structured by sections. In this case, it must follow the following structure: Introduction-Objective- Methods-Results- Conclusions.

The summary should be informative and completely self-explanatory, briefly presenting the topic, indicate the scope of the experiments, indicate significant data and point out the main findings and conclusions. The abstract should not exceed 254 words. Standard nomenclature should be used and abbreviations should be avoided.

Literature should not be cited.

**Introduction:** Presents brief, clear and appropriate background information.

**Objective:** Start with a verb in the infinitive ("Evaluate...", "Determine...", etc.). This must be concrete (not include aspects that go into methods). Explicitly indicate what information is expected to be obtained.

**Methods:** Standard nomenclature should be used and abbreviations should be avoided. AND mention the design of the study. It is written in the past tense.

**Results:** Complete sentences, active verbs and the third person must be used, and it must be written in the past tense.

**Conclusions:** Conclusions and recommendations that are not found in the text of the manuscript should not be given in the abstract.

**Keywords:** Article; Format; manuscript; style; template (keywords in alphabetical order and separated by semicolons. Words found in the title do not need to be given as keywords). Use terms from the latest Headings list of medical topics (MeSH) of Index Medicus. A more general term can be used if a suitable MeSH term is not available.

## Presentation and participation.

Presentation mode: poster/Oral communication/Plenary dissertation.

Participation mode: active, virtual, *offline*.
